
The affiant, Shelby Bennett, being duly sworn, deposes and says as follows:

- 3. On December 13, 2019 I was in a Rules Infraction Board (RIB) hearing for Ms. Garko. She was screaming and cussing during her hearing, so it was terminated due to her non-compliance. Ms. Garko dropped to the floor. I directed her several times to stand to her feet and walk. She finally complied and Officer Arthur Jones and I escorted Ms. Garko back to the Residential Treatment Unit (RTU).
- 4. Once inside the recreation room, Ms. Garko was kicking and trying to pull away from us and threw her head back and spit on Officer Jones' left chest area and arm. She then started to kick and had to be placed on the ground. Ms. Garko was trying to pull her hands out of the handcuffs. She continued to spit and did spit on another inmate. She turned in my direction and pulled her head back like she was going to spit on me, so I deployed OC to protected myself and others from being spit on.
- 5. The OC was ineffective because Ms. Garko turned her face away.
