an inmate at the Ohio
Reformatory for women.
as I write this im presently
living behind a Door living
in fear. of the Ohio
Department of Rehabilitation
and Correction. I need to
tell everyone out there
and especially any legal
professionals or organizations
about the suffering I've
been through and
still continue to live with.
when I came to prison twelve
(12) years ago I had
two healthy eyes
with vision (bad vision
but still vision)
and now I'll be leaving
prison in 2027 with
only one eye.
let me tell you how
the ODRC let me
slowly go blind in my
right eye and then
covered it up along
with abuse ~~and that's~~
and how my own
personal injury lawyer

attorney Sean, C. Buchanan
of the law firm
Slater and Zurz in Akron
Ohio, conspired to and
succeeded in covering
it up for the state
and took a \$200,000
pay off from the
ODRC to let
me be abused continually
and suffer medical
malpractice pain and suffering
until I lost my eye.
~~this all happened between~~

~~My~~ I want to let people
know who, did it,
why they did it and
how they did it.
The public needs to
be aware of
exactly which crooked
attorneys would
let their own injury
clients or their clients
family or friends possibly
die or be permanently
injured and cover it
all up for a pay off
from the ones who did it.
and also stole over
\$102,000 of my
bank account my father
left me.

Part one: The biggest mistake of my life, gave me the most Character and Strength.

at ORW back in 2017 I was in a unit called the RTU. Residential Treatment Unit. for some reason ORW and the ODRC want us to believe that ~~with~~ with all the Nurses "crooked and negligent and all the caring medical staff in this unit inmates should feel safe" (as they should) BUT NO. at ORW the "nurses" in the residential Treatment unit are anything but. they are Corrupt, Deliberately indifferent to serious medical and mental health needs of inmates and negligent, hiding their Abuses and

Keeping Their atrocities
hidden under The
Rug. The inmates in The RTU
unit are mostly mentally
unstable with mild to
serious mental health issues.
Suicidal behaviors are
serious and very active
here. In this unit
and all through my stay
at CRW RTU
and Dayton Correctional
Institution (another Ohio women's prison
I was in During my
last 13 years.

I have never ~~been~~ had
any mental health
treatment, or serious
medical treatment.

I am and have been suicidal
During my stay,
but instead of mental
health treatment for
hanging from a shoelace on my
own vent in my cell
I could have died.

and all they did was
punish me for being
suicidal and put me
in "The hole"
for believe it or not
"misuse of a shoelace
as contraband"

This officer Erika Dillon
at Dayton Correctional
institution was always

(I guess I made her look bad?

The date of this incident
was January 27, 2021

The exact date when I received
a legal letter from my

"corrupt attorney" Sean Buchanan
telling me he was doing
nothing about my case,

he said Oh well,

and actually told me

"pretty much" after
I said to him,

are you really doing
this to me?

after he did this to
me I hung myself.

and when the 90 finally
came and cut me
Down I was taken to
the hole and punished.
This is my life.
