ORDER OF THE MAGISTRATE

On March 3, 2021, plaintiff's counsel, Sean Buchanan, filed a motion to withdraw. Motions to withdraw are governed by L.C.C.R. 19, which sets forth that counsel may withdraw "[u]pon written application served upon the client, showing good cause for substitution or withdrawal of trial counsel." L.C.C.R. 19(2). While the motion states that plaintiff has been informed of the reason for the withdrawal in writing, counsel does not set forth the reason in his motion.

Because the motion does not comply with L.C.C.R. 19, it is DENIED. However, counsel may file an amended motion to withdraw that complies with L.C.C.R. 19 within 7 days of the date of this order.
