Enclosed please find the Motion for Relief from Judgment filed April 5, 2023. Plaintiff's response is due April 26, 2023. Any Reply is due May 3, 2023. Also enclosed is a current bill for services. Finally, enclosed are copies of the statements received from Premier Bank per your request.

I also enclose a Motion to Withdraw as Counsel and proposed Order submitted to Judge Breaux.

We have represented you effectively throughout this matter. We obtained extensions of the Statute of Limitations from Slater and Zurz to preserve your rights to claim against them for the allegations of legal malpractice. We reviewed the partial medical records provided by you. These were incomplete and disorganized. We obtained the complete records from the ODRC to evaluate your claims. We obtained a medical legal report from Dr. Faucett. We determined that the Statute of Limitations has expired on a potential claim against Slater and Zurz. We have discussed with you the possibility of you still pursuing a medical malpractice claim against ODRC based on the report of Dr. Faucett. We obtained a review of your medical records and an Affidavit from Dr. Keogh to defend the claim for revivor of the Susan Miller judgment and to potentially use regarding overcoming the statute of limitations regarding your claim against ODRC. A copy of her affidavit is also enclosed.

In a voicemail and written correspondence to me and in a letter to Mr. Fortado you accused us of working with Slater and Zurz and ODRC to protect them from your claims. You claimed we "set you up" and stole money from you.
