On April 21, 2021, plaintiff filed a motion for leave to conduct discovery.
Defendant has not filed a response.

Sean Buchanan { Counsel for plaintiff has recently withdrawn from this case, and plaintiff has failed to respond to defendant's pending motion to compel discovery. However, it is unclear to the court whether plaintiff herself has been served with the motion to compel, and, in any event, the discovery deadlines that were set in this case have expired.

Therefore, in the interest of justice, the court finds that a new trial order is warranted. Accordingly, plaintiff's April 21, 2021 motion for leave is GRANTED. Defendant's motion to compel discovery is DENIED as moot. The court's August 17, 2020 order is VACATED, and the court ORDERS the following:

- 1) Trial is rescheduled for *January 26, 2022, at 10:00 a.m.*, at the Dayton Correctional Institution via Zoom videoconference;
- 2) A pretrial conference via telephone is scheduled for *December 21, 2021, at 10:30 a.m.*;
- 3) Plaintiff shall furnish defendant with the names of any expert witnesses and a copy of their reports on or before *July 16, 2021*;
- 4) Defendant shall furnish plaintiff with the names of any expert witnesses and a copy of their reports on or before *August 20, 2021*;
